

## ORDINANCE 12

AN ORDINANCE OF THE TOWNSHIP OF GRANT, COUNTY OF INDIANA, AND COMMONWEALTH OF PENNSYLVANIA, IMPOSING A WEIGHT LIMITATION ON TOWNSHIP ROADS SITUATE WHOLLY WITHIN THE TOWNSHIP OF GRANT, COUNTY OF INDIANA, AND COMMONWEALTH OF PENNSYLVANIA, AND BEING IDENTIFIED AS FOLLOWS:

Township Road 450, known as Lowman Road;  
Township Road 467, known as Shields Road;  
Township Road 520, known as Burns Road;  
Township Road 543, known as Snyder Road;  
Township Road 547, known as Lentz Road;  
Township Road 549, known as Magnolia Road;

**BE IT ORDAINED AND ENACTED** by the Supervisors of the Township of Grant, Indiana County, Pennsylvania, as follows:

**SECTION 1:** The following words, when used in this ordinance, shall have the meaning subscribed to them in this section except when the context clearly indicates or requires a different meaning.

A. "Person" – Any natural person, partnership, association, firm or corporation.

**SECTION 2:** It shall be unlawful for any person to operate or cause to be operated any motor vehicle over, across or upon Township Road 450, known as Lowman Road; Township Road 467, known as Shields Road; Township Road 520, known as Burns Road; Township Road 543, known as Snyder Road; Township Road 547, known as Lentz Road; Township Road 549, known as Magnolia Road; Township Road 550, known as Big Two Road; Township Road 555, known as Beatty Road; Township Road 627, known as Donahey Road; Township Road 671, known as Braughler Road; Township Road 673, known as Mumau Road; Township Road 711, known as Stewart Road; Township Road 782, known as Raspberry Road; Township Road 786, known as Sheesley Road; Township Road 788, known as Julock Road; Township Road 790, known as Kinnan Road; Township Road 792, known as Ryen Road; Township Road 793, known as Oberlin Road; Township Road 820, known as Savan Road; Township Road 830, known as Rairigh Road; Township Road 831, known as Hetzler Road; Township Road 836, known as Buterbaugh Road; Township Road 837, known as Hartman Road; Township Road 840, known as Montgomery Church Road; Township Road 850, known as Kriner Bottom Road; Township Road 851, known as East Run Road; Township Road 852, known as Smith Street; Township Road 853, known as Richmond Road; Township Road 880, known as Pinevale Road; Township Road 910, known as Deckers Point Road; Township Road 911, known as Pickering Run Road; Township Road 932, known as Walker Road; Township Road 940, known as Nashville Road; Township Road 960, known as Grant Street; Township Road 961, known as Pollock Road; and Township Road 981, known as Mill Run Road, having a gross weight in excess of 20,000 pounds.

**SECTION 3:** Any person operating a motor vehicle in violation of Section 2 herein shall be fully liable and responsible for all damage he has caused to the said Township Road as a result of the violation of this Ordinance, which obligation shall be in addition to any other penalties herein provided.

**SECTION 4:** The Supervisors of Grant Township are hereby authorized and empowered to prescribe a form of bond which may be posted by any person desiring to operate a motor vehicle upon the Township Road described herein in violation of Section 2 of this Ordinance, the amount of said bond to be fixed by the Supervisors of Grant Township and the condition of said bond to be that if the obligors shall promptly and faithfully restore the said Township Road which they desire to use to its condition prior to the use of the same, then the said bond and obligation shall be null and void, otherwise it shall remain in full force and effect.

**SECTION 5:** Any person violating the provisions of this Ordinance shall upon summary proceedings brought in the name of the Township before any District Justice be fined upon

conviction in an amount of not less than \$50.00 nor more than \$300.00, or in default thereof be sentenced and committed to the Indiana County Jail for a period not exceeding 15 days and be directed to pay the costs of prosecution and to make restitution to the Township of Grant for any damage to the roads of the Township caused as a result of such violation.

**SECTION 6:** If any section, provision or part of this Ordinance shall be held unconstitutional, such unconstitutionality shall not affect the validity of the remaining section, provisions or parts of this Ordinance.

**SECTION 7:** This Ordinance shall be effective five days after adoption.
